Dear Members of the Council and County Executive Ehlmann,

The St. Charles County Police Department has been offered a donation of five (5) new Glock 17 pistols with red dot sights and duty holsters from the 505 Foundation. The 505 Foundation, a not-for-profit 501(c)(3) was created by the children of Retired Sgt. John Bush, DSN 505. Sgt. Bush worked at the St. Charles County Sheriff's Dept. and then the St. Charles County Police Dept. for nearly five decades. For the last 15 years of his distinguished career, Sgt. Bush held the position of "Range Master". Sgt. Bush was devoted to keeping our officers safe by ensuring they had the best equipment and were trained well with that equipment. The 505 Foundation holds several fund raising events throughout the year and all the money raised is donated to local Police Departments to enhance training and equipment needs. Last year the 505 Foundation donated \$6,000 for the purchase of simmunition training pistols for use during force-on-force training. The generous donation of the new Glock pistols and holsters this year will aid in the Department's transition to "red dot" system sights. These new sight systems can greatly improve an officer's shooting accuracy and therefore keep them safer in a deadly force encounter.
