AN ORDINANCE AMENDING THE 2023 BUDGET AS ADOPTED BY ORDINANCE 22-087, AS AMENDED, FOR THE REMOVAL OF A WIRELESS COMMUNICATIONS/NETWORK SPEC I POSITION AND THE ADDITION OF A WIRELESS COMMUNICATIONS/NETWORK SPEC III POSITION IN THE DEPARTMENT OF EMERGENCY COMMUNICATIONS OF ST. CHARLES COUNTY

WHEREAS, in order to attract more qualified candidates, the Department of Emergency Communications is requesting that this open position be changed from Wireless Communications/Network Spec I to Wireless Communications/Network Spec III in the 2023 budget; and

WHEREAS, the change to a Wireless Communications/Network Spec III position will require an amendment of the St. Charles County, Missouri 2023 Annual Budget approved by this Council by Ordinance 22-087 on December 19, 2022; and

WHEREAS, it is necessary to amend the budget to reflect the amendment of the classification of this FTE; and

WHEREAS, the proposed change will also give the flexibility to consider hiring a Wireless Communications/Network Spec II position if no Wireless Communications/Network Spec III candidates are identified in the hiring process; and

WHEREAS, the Department of Finance has reviewed and determined that the Department of Emergency Communications has sufficient funds in their 2023 departmental budget to account for this proposed change of deleting a Wireless Communications/Network Spec I and adding a Wireless Communications/Network Spec III; and

WHEREAS, the St. Charles County Charter, Article VI, Section 6.208 authorizes the County Council to provide by ordinance any and all procedures for administering the budget that are necessary and that do not conflict with the language contained in the Charter.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF ST. CHARLES COUNTY, MISSOURI, AS FOLLOWS:

Section 1. The budget of St. Charles County, Missouri, for fiscal year 2023 as initially adopted by ordinance 22-087, in the Department of the St. Charles County Emergency Communications (273), page 288 of the aforementioned Budget, as amended, is hereby further amended as follows:

1. Delete one (1) full-time Wireless Communications/Network Spec I, pay grade C3, for an amended allocation of zero (0) Wireless Communications/Network Spec I position, pay grade C3.
2. Add one (1) full-time Wireless Communications/Network Spec III, pay grade C9, for an amended allocation of four (4) Wireless

Communications/Network Spec III positions in total,
pay grade C9.

Section 2. This ordinance shall be in full force and effect as of
passage and approval.
