AN ORDINANCE AUTHORIZING THE COUNTY EXECUTIVE OR HIS DESIGNEE TO EXECUTE CONTRACT AMENDMENT #006 FOR AUTOPSY SERVICES WITH THE MISSOURI DEPARTMENT OF SOCIAL SERVICES FOR CHILD DEATH AUTOPSY SERVICES

WHEREAS, the Missouri Department of Social Services has provided Contract Amendment #006 for Autopsy Services to the St. Charles County Office of the Regional Medical Examiner for Child Death Autopsy Services; and

WHEREAS, the original contract for these services was approved in Ordinance 18-098 in October 2018; and

WHEREAS, Contract Amendment #006 for Autopsy Services is a continuation of that contract; and

WHEREAS, the Contract services the program for the period of July 1, 2023 through June 30, 2024; and

WHEREAS, all other terms and conditions shall remain unchanged; and

WHEREAS, the Contract Amendment #006 for Autopsy Services between the Missouri Department of Social Services and St. Charles County Office of the Regional Medical Examiner provides for payments to the Regional Medical Examiner for a continuation of child death autopsies performed, in an amount up to \$2,500 per autopsy; and

WHEREAS, the Contract Amendment #006 for Autopsy Services outlines the duties of the Missouri Department of Social Services and St. Charles County Office of the Regional Medical Examiner; and

WHEREAS, it is in the public interest for the St. Charles County Office of the Regional Medical Examiner to participate in the Contract Amendment #006 for Autopsy Services to receive assistance for the residents of St. Charles County; and

WHEREAS, Chapter 70, Revised Statutes of Missouri, authorizes intergovernmental agreements between political subdivisions for the purposes herein set out.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF ST. CHARLES COUNTY, MISSOURI, AS FOLLOWS:

Section 1. The County Executive, or his designee, is hereby authorized to execute the Contract Amendment #006 for Autopsy Services with the Missouri Department of Social Services related to Contract #: AOC18380173.

Section 2. The Contract Amendment #006 for Autopsy Services shall be substantially the same in form and content as that attached hereto as **EXHIBIT A**.

Section 3. Compliance with all the terms of the Contract Amendment #006 for Autopsy Services shall be the responsibility of the St. Charles County Office of the Regional Medical Examiner.

Section 4. This ordinance shall be in full force and effect from and after the date of its passage and approval and such contract amendment authorized herein shall be valid upon its execution as required by Chapter 70 of the Revised Statutes of Missouri.
