RE: St. Charles County Council District 6 Appointment



Pursuant to Article II, Section 2.1000, as amended, of the St. Charles County Home Rule Charter, a vacancy in the office of the County Council shall be filled by the County Executive subject to confirmation by the Council. By letter dated August 22, 2019, Mike Klinghammer tendered his resignation as a member of the St. Charles County Council representing District 6, effective September 3, 2019. Thus, a vacancy exists in the office of County Council, District 6. The Charter requires the person appointed to fill this vacancy shall be a member of the same political party as the previous occupant (if so affiliated).

It is my pleasure to inform you that I hereby appoint Nancy L. Schneider, of the city of St. Charles, as a member of the St. Charles County Council to represent District 6 for a term ending January 1, 2021, at which time the individual duly elected to the County Council to represent District 6 at the general election in November 2020, will assume this position.

Nancy Schneider retired in December 2016 after serving 26 years as an associate and then circuit judge in St. Charles County, having been elected by the voters five times. She was chosen by the 11th Judicial Circuit judges twice to serve as the Presiding Judge and served on the 11th Circuit Attorney Disciplinary Committee. In addition, she served on various Missouri Supreme Court Committees including the Budget and Education Committees. Prior to serving on the bench, Ms. Schneider was in private law practice for 10 years, was a prosecutor for the Juvenile Court, and

was employed at ACF Industries for 10 years. Ms. Schneider is a graduate of St. Charles High School, Lindenwood University, and St. Louis University School of Law.

In addition to her legal work, Nancy Schneider has been active in the community and particularly in organizations that positively impact young people. At the state level, Nancy served on the Board of Governors for Truman University, including a term as board president. Locally, Nancy served on the St. Charles City-County Library Board and the County's Board of Equalization and currently serves as president of the Community and Children's Resource Board. She is also a volunteer OASIS tutor at Null Elementary School.

By this correspondence, I hereby request your concurrence in confirming the appointment of Nancy L. Schneider to the St. Charles County Council, District 6, on the Consent Agenda of the St. Charles County Council at your meeting on Tuesday, October 15, 2019. I would appreciate your favorable consideration of this request.
