Emergency Bill No. 4981 – Sponsored by: Mike Elam, AN EMERGENCY ORDINANCE AUTHORIZING EXECUTION OF DOCUMENTS FOR RECEIPT OF GRANT FUNDS IN THE AMOUNT OF TWO MILLION NINE HUNDRED FOUR THOUSAND AND FOUR HUNDRED NINETY NINE DOLLARS (\$2,904,499) FROM THE U.S. SMALL BUSINESS ADMINISTRATION (“SBA”) FOR A SHUTTERED VENUE OPERATORS GRANT (“SVOG”)

Council Chair Elam explained the County applied for the grant in early spring and government venues were the last approved. Elam stated the grant needs to be signed and accepted by Wednesday, July 21, 2021.

Joann Leykam, Director of Administration noted the grant funds were approved by President Trump in December of 2020 and the County has been tracking the progress and has been in constant contact with grant processors. Leykam stated the County was notified of funding approval on Wednesday, July 14 so a special Council meeting was called to meet the acceptance deadline of Wednesday, July 21, 2021.

There being no further discussion, Council Chair Elam requested the following roll call vote: Councilman Cronin – absent, Councilman Brazil – absent, Councilman Elam – yes, Councilman Hammond – yes, Councilman Hollander – absent, Councilwoman Schneider – absent, Councilman White – yes.

Emergency Bill No. 4981 was approved 4-3.

Councilman Hammond motioned to adjourn, seconded by Councilwoman Schneider, and approved by all present.

The meeting adjourned at 4:19 p.m.
