## Blind Turkey Toss Disc Golf Tournament Hosted at Quail Ridge Park

*St. Charles County, Missouri* – Compete for cash prizes, trophies, and a Thanksgiving turkey at the 10th annual Blind Turkey Toss Disc Golf Glow Tournament at Quail Ridge Park (5501 Quail Ridge Parkway) near Wentzville, beginning at 5:30p.m., on Saturday, Nov. 17. Using baskets lined with more than 100 glow sticks to mark the course, a shotgun start will begin the 18-hole contest. Trophies will be awarded for first-, second-, and third-place finishers in the tournament. In addition, there will be a “blind toss,” and the closest to the basket wins a frozen Thanksgiving turkey.

The entry fee for this individual tournament is \$10. Registrations will be accepted from 4:30-5:15 p.m., the day of the tournament at Shelter #2. The tournament is open to the first 72 registered contestants. A limited number of glow sticks will be available for purchase prior to the event.
