<b>COVID-19 deaths</b>	54


*\*Tests are being performed at both the Missouri State Laboratory and through private testing laboratories. The number of pending tests is reported to the Department of Public Health by the Missouri State Laboratory only; private labs do not report pending tests to the health department.*

## **Additional Information:**

### ***Quarantine Procedures/Expectations***

The St. Charles County Department of Public Health and other public health agencies require those who have tested positive for COVID-19 and others who are close contacts of those individuals to quarantine according to guidelines set by the [Centers for Disease Control and Prevention](#). Quarantine is used to keep someone exposed to the COVID-19 virus away from others and is focused on preventing the spread of disease.

In St. Charles County, these individuals are contacted by letter from the department which outlines expectations and procedures for the quarantine process. These expectations include:

- The individual signs and agrees to follow the recommendations.
- The individual must stay inside their residence during the quarantine process – usually 14-15 days.
- If social distancing inside the home is not possible, the individual must wear a face mask around others.
- The individual must monitor and report temperatures and symptom progression to the department.
- The individual will receive a letter of release from the department following completion of the quarantine period. Letters from medical providers or employers do not release an individual from county-mandated quarantine.

### ***Guidelines for Opening and Operating Community Pools and Aquatic Facilities***

Memorial Day traditionally signals the start to pool season in our area. For those entities choosing to open a community pool or public aquatic facility this month, the Department of Public Health offers guidelines for employees and guests designed to increase everyone's health and safety:

- Follow [CDC considerations](#) for safe facility operations.
- Enforce social distancing guidelines that recommend at least a 6 foot distance both in and out of the water.
- Do not allow deck furniture to be rearranged or grouped in areas with less than 6 feet of space in-between.
- Consider reducing bather loads/facility occupancy to account for social distancing.
- Clean and disinfect doors, gates, furniture, railings, restrooms and other commonly touched surfaces regularly.
- Clean, disinfect and regularly test water systems.
- Encourage hygiene and respiratory etiquette for individuals in and out of the water.
- Post signage encouraging social distancing, hand washing and other recommended practices.
- Follow guidance outlined by the [St. Charles County Aquatic Facility Code](#) and other community regulations.

### ***COVID-19 Guidelines for St. Charles County Residents and Employers***

To accompany County Executive Steve Ehlmann's directive to follow Missouri's "Show Me Strong Recovery" plan for reopening during the COVID-19 pandemic, the Department of Public Health offers recommendations for residents to increase health and safety measures.
