

NOTICE TO BIDDERS

St. Charles County is accepting bids for the following:

SEALED BID 13-130 Asphalt Overlay Project

Sealed Bids will be received by the St. Charles County Purchasing Manager, 201 North Second Street, Suite 541, St Charles, Missouri 63301, Until 10:00 A.M., (prevailing Central Time) on Thursday, August 8, 2013 and will thereafter be publicly opened and read aloud in Conference Room 431.

The proposed work includes the furnishing of materials, tools, equipment and labor necessary to construct **Asphalt Overlay Project** on Diehr Road between Highway DD and Hopewell Road, on Peine Road between Highway 61 and Spring Mill, on Josephville Road between Mexico Road and Josephville Park, on Gutermuth Road between Motherhead Road and Old Gutermuth Road, and on St Peter-Cottleville Road between Weise Road and Cottleville Parkway and between Mid Rivers Mall Drive and Ohms Road in St. Charles County, Missouri.

The project shall include all work incidental to the supply and laying of approximately 8,150 tons of Type "BP-1" asphaltic concrete materials, to be paid for by the ton. Milling at entrances and side streets of approximately 3,150 square yards will be paid by the square yard.

Plans and specifications may be obtained on and after Wednesday, July 17, 2013 for a **\$20** non-returnable fee at the office of the St. Charles County Highway Department, 201 N. Second Street, Suite 429, St. Charles, Missouri. Sets will be mailed upon request for a non-returnable fee of **\$40** after a check is received. Make all checks payable to "**St. Charles County Highway Department.**"

Each Bid must be accompanied by a Cashier's Check or Certified Check, or a Bid Bond executed by the Bidder and an approved Surety Company and payable to the County, in an amount not less than Five Percent (5%) of the Sum Total of the Base Bid.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

Missouri Annual Wage Order 20, as amended June 28, 2013, shall be in effect for this project.

The DBE goal for this letting is a minimum of **0%** of the total contract amount.

TRAINEES: There is no trainee requirement for this project.

All contractors and subcontractors are subject to and must comply with the Safety Program Training requirements of Section 292.675 of the Revised Statutes of Missouri.

All bidders must meet the MoDOT requirements as a CONTRACTOR at least seven (7) days prior to bid opening in accordance with Section 102.2 of the St. Charles County Standard Specifications for Arterial Highway Construction.

A Performance Bond and Payment and Materials Bond are required.

The COUNTY reserves the right to reject any and all Bids, to waive informalities therein to determine the lowest, responsive, responsible bidder, and to approve the bond. No Bid may be withdrawn for a period of sixty (60) days subsequent to the specified time for receipt of Bids.

The COUNTY intends to issue the Notice to Proceed on or about September 30, 2013.

The County of St. Charles hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.
