



**\*ADDITIONAL TERMS:**

- Age category definitions:
  - Children – under five (5) years of age
  - Youth – five (5) to seventeen (17) years of age
  - Adult – eighteen (18) to fifty-nine (59) years of age
  - Senior Adult – sixty (60) years of age or older
- All admissions/passes are non-refundable and non-transferable
- Annual passes are valid for January 1 – December 31 for the year specified
- Family passes cover a maximum of two (2) adults, plus three (3) children twenty-two (22) years of age or younger, living in the same household
- Annual passes purchased on or after August 1<sup>st</sup> are half price
- Annual passes renewed by December 31<sup>st</sup> for the next year receive a 10% discount
- Kinetic Park General Admissions do not include extreme activities as designated by parks staff
- Kinetic Park Under 3-year-old General Admission requires close parent or guardian supervision, at all times
- Kinetic Park Extreme admissions include climbing wall session and use of skate park
